Unlike the legacy Access Management Systems, which are standalone and are completely dependent on hardware, truMe is a state-of-the-art platform, which ensures great flexibility to write access rules, gives real-time visibility to access events and has in-built reporting & data analytics.

## State-of-the-art Solution

- Complete visibility of multiple locations from one place
- Full visibility & control on time usage by each customer helps enforce Agreement in terms of days & time - realtime and without friction
- Full visibility on employees' time & attendance
- Particularly useful in enforcing Agreement in case of unconventional usage - one hour, one day, number of days in a week/ month, access to more than one centre, access to centres in one city/ many cities etc.

# truMe: How it Works

- The Wellness Centre Chain adopts truMe platform
- An Admin Module and a number of Reception Modules for each centre are set-up with login credentials
- Client decides the nature and periodicity of reports
- Each employee and customer downloads truMe App. If the Wellness Centre has its own App, truMe integrates with that App
- Customers receive their digital Access Pass on the App, basis the plan subscribed to & payment made
- At the time of entry/ exit, the authorized customer scans her face or the location QR code on a tablet to open the door. truMe records the time of entry, exit and occupancy of each customer
- All employees also scan the QR code while entering and exiting the centre. truMe integrates with Client's HRIS to push periodic time & Attendance Reports of employees
